Memorandum in Support:

Metzenbaum filed a Motion to Strike AT&T's Motion to Dismiss on April 29, 2003.

On May 5th 2003, Attorney Examiner Scott Farber issued an Order that Metzenbaum to answer AT&T's Motion to Dismiss by May 16, 2003.

On May 16, 2003 Metzenbaum called the Docketing Department and found out that Mr Farber never ruled on the Motion to Strike.

Metzenbaum contacted Mr Farber who told Metzenbaum that he was waiting for Metzenbaum to file his response to the Motion to Dismiss before he Ruled on the Motion to Strike.
