The Commission finds:

- (1) On April 13, 1998, Commission staff served notice of preliminary determination upon Triad Transport, Inc. (Triad or respondent) in accordance with Rule 4901:2-7-12, Ohio Administrative Code (O.A.C.), alleging violations of the Commission's Transportation Safety Rules.
- (2) On December 2, 1998, and after several continuances, Triad and staff docketed a Settlement Agreement stating that this matter has been resolved. Under the terms of the settlement agreement respondent agrees to pay a civil forfeiture in the amount of \$630 and respondent agrees that the violation shall be included in its Safety-Net Record and history of violations, insofar as it may be relevant for purposes of determining future civil forfeitures.
