ENTRY

The Commission finds:

- (1) On April 13, 1998, Commission staff served notice of preliminary determination upon Triad Transport, Inc. (Triad or respondent) in accordance with Rule 4901:2-7-12, Ohio Administrative Code (O.A.C.), alleging violations of the Commission's Transportation Safety Rules.
- (2) On December 2, 1998, and after several continuances, Triad and staff docketed a Settlement Agreement stating that this matter has been resolved. Under the terms of the settlement agreement respondent agrees to pay a civil forfeiture in the amount of \$630 and respondent agrees that the violation shall be included in its Safety-Net Record and history of violations, insofar as it may be relevant for purposes of determining future civil forfeitures.
- (3) With the adoption of this settlement agreement, this proceeding should be closed as a matter of record.

It is, therefore,

ORDERED, That the settlement agreement entered into between staff and respondent is approved and adopted by the Commission. It is, further,

ORDERED, That this case is closed as a matter of record. It is, further,


