Sprint Nextel Corporation ("Sprint Nextel") acquired Nextel Partners, Inc. ("Nextel Partners") in a transaction approved by the Federal Communications Commission on June 16, 2006. The companies completed the acquisition on June 26, 2006. With the completion of the transfer, Sprint Nextel acquired all of the outstanding capital stock of Nextel Partners and now owns 100% of its common stock. Sprint Nextel transferred control of Nextel Partners' wireless licenses to Nextel WIP Corp., a wholly-owned subsidiary of Sprint Nextel.

Nextel Partners affirms that it has obtained all necessary federal authority to conduct operations in the state of Ohio. A list of the licenses that Nextel Partners holds in Ohio is attached as Exhibit 2 to this Application. Nextel Partners' licenses in Ohio are held by two of its wholly-owned subsidiaries: Nextel WIP License Corp. and Nextel WIP Expansion Two Corp. The licensees included in this list are also listed in Part VI of the Telecommunications Application Form. Nextel Partners should be added to the list of CMRS providers operating in Ohio.
