Dear Ms. Crockron:

On October 6, 2000, Cincinnati Bell Telephone Company (CBT) filed a proposal to revise its General Exchange Tariff, PUCO No. 8, to provide a special promotion to residential customers who subscribe to Call Waiting or Call Forwarding Variable Service. Residential customers who met the terms of this promotion would receive a waiver of the nonrecurring charge of \$6.50 per line. This special promotion was scheduled to be in effect from October 6, 2000 through November 6, 2000.

However, due to a delay with the promotional material, CBT requests permission to amend that filing to revise the promotional period to begin October 27, 2000 and to end on November 30, 2000. CBT apologizes for any inconvenience that this may have caused.

B. RATES

3. NONRECURRING CHARGES
