ENTRY NUNC PRO TUNC

The Commission finds:

- (1) The applicant in this certification application, CCCOH, Inc. dba Connect! (CCCOH), has sought authority from the Commission to provide, within its first 24 months of operation, resold and facilities-based local exchange service in all or portions of Clark, Cuyahoga, Delaware, Fairfield, Fayette, Franklin, Gallia, Geauga, Greene, Hamilton, Hocking, Lake, Licking, Madison, Mahoning, Medina, Montgomery, Perry, Pickaway, Portage, Stark, Summit, and Trumbull counties, Ohio.
- On February 24, 2000, the Commission issued a finding and order in this case by which it ostensibly granted the certification application filed by CCCOH in this case. However, within Finding (1) of that finding and order, due to an inadvertent drafting error, the Commission failed to identify Franklin County, Ohio as being among the counties in which the applicant had sought certification. Moreover, and for the same reason, the Commission failed within the second ordering paragraph of that finding and order to identify Franklin County, Ohio as being among the counties in which the applicant should now be authorized to provide local exchange telecommunications service.
- (3) Both of these inadvertent errors should now be corrected through this entry *nunc pro tunc*.

It is, therefore,

ORDERED, That, in accordance with the above findings, the first finding of the Commission's February 24, 2000 Finding and Order in this case is hereby amended, *nunc pro tunc*, so as to identify Franklin County, Ohio, as being among the counties in which the applicant has sought certification in this case. It is, further,

ORDERED, That, in accordance with the above findings, the second ordering paragraph of the Commission's February 24, 2000 Finding and Order in this case is hereby amended, *nunc pro tunc*, so as to identify Franklin County, Ohio, as being among the counties in which the applicant has been certified, under the authority granted in this case, to provide local exchange telecommunications service. It is, further,

ORDERED, That a copy of this entry be served upon parties of record in this case.
