Cincinnati Bell Telephone Company (CBT) proposes to revise **Out of Territory Services Tariff**, PUCO No. 1 to provide a special promotion of its **Calling Name and Number Service and Reveal Privacy Management Service** to residential customers.

Residential customers who meet the terms of this promotion will receive a **waiver of the nonrecurring charge of \$8.50 and the first month's recurring charges** for Calling Name and Number Service and Reveal Privacy Management Service. This special promotion will be in effect from August 6, 2001 through September 30, 2001.
