Cincinnati Bell Telephone Company (CBT) proposes to revise its **General Exchange Tariff PUCO No. 3** in order to conduct a **promotion** on its business exchange access service. Customers who subscribe to **additional business access lines** during the promotional period will receive a waiver of the nonrecurring charge associated with installation of the lines. The promotional period will run from July 16, 2001 through September 30, 2001.
