ENTRY

The Commission finds:

- (1) The above-captioned applications were filed with the Commission seeking certificates of public convenience and necessity for the transportation of household goods. Protests to all of these applications were filed on behalf of multiple motor carriers.
- (2) The applicants in Case Nos. 96-162-TR-ACE, 96-1244-TR-ACE, 97-318-TR-ACE, and 97-346-TR-ACE filed letters or advised the attorney examiners that they no longer wish to pursue their applications. The applicants in Case Nos. 94-538-TR-ACE and 97-148-TR-ACE have failed to prosecute their applications or contact the attorney examiner regarding their applications, despite numerous attempts to schedule prehearings and hearings. The applicant in Case No. 98-1025-TR-ACE filed an incomplete application and failed to correct the deficiencies or contact the attorney examiner when requested to do so. Accordingly, the applications in Case Nos. 94-538-TR-ACE, 96-162-TR-ACE, 96-1244-TR-ACE, 97-148-TR-ACE, 97-318-TR-ACE, 97-346-TR-ACE, and 98-1025-TR-ACE should be dismissed and these cases should be closed of record.

It is, therefore,

ORDERED, That the applications in Case Nos. 94-538-TR-ACE, 96-162-TR-ACE, 96-1244-TR-ACE, 97-148-TR-ACE, 97-318-TR-ACE, 97-346-TR-ACE, and 98-1025-TR-ACE be dismissed and these cases be closed of record. It is, further,

ORDERED, That a copy of this entry be served all parties of record.




