## **ENTRY**

The attorney examiner finds:

- (1) On March 15, 2001, The Dayton Power and Light Company (DP&L) filed its 2000-2001 long-term forecast report (LTFR).
- (2) On May 29, 2001, the staff of the Commission (staff) filed a motion for a hearing in this case. Staff's motion notes that, Section 4935.04(D)(3)(b), Revised Code, requires the Commission to conduct a hearing at least once every five years regarding the latest LTFR a utility files. Staff states that the Commission last conducted a hearing for a DP&L LTFR in Case No. 94-205-EL-FOR, regarding its 1995 LTFR. Staff notes that, as five years have elapsed, the Commission is required to conduct a hearing regarding DP&L 's 2000-2001 LTFR.
- (3) Staff's motion is reasonable and should be granted. Accordingly, the Commission will schedule a public hearing in this matter to begin at 10:00 a.m., on July 24, 2001, in Hearing Room 11-F, at the offices of the Commission, 180 East Broad Street, Columbus, Ohio.
- (4) DP&L should cause the following notice to be published once, not less than 15 days nor more than 30 days prior to July 24, 2001, in at least one newspaper of general circulation in each county of the DP&L's service area:
