Dear Ms.Crockron:

Cincinnati Bell Telephone Company (CBT) proposes to revise its General Exchange Tariff, PUCO No. 8 to do a special promotion of its Calling Name and Number Service and its Reveal Privacy Management Service. CBT will waive the nonrecurring charge of \$6.50 per line to add Calling Name and Number and/or Reveal Privacy Management during this special promotion.
