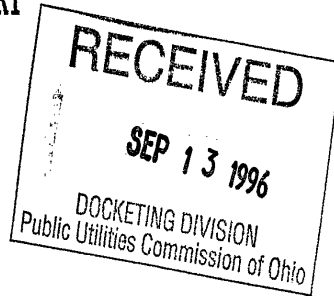



MOTIONS TO AMEND ALL COMPLAINTS LISTED IN THE CAPTIONED CASES:

COMPLAINANTS HEREBY MOVE the Commission TO AMEND each and every
 complaint in the captioned cases in accordance with the following
MOTIONS:

1. STRIKE from the facing page of each complaint, all wording
 which follows the name and address of the Ohio Bell Telephone Company,
 and

2. STRIKE from page two [2] of each complaint, ALL WORDING
following the words "OHIO BELL" where they first appear in the last
 paragraph of page two [2] and

3. ADD in each complaint the FOLLOWING WORDS after the then final words of OHIO BELL appearing in the last paragraph of page two [2]:

"for unlawfully, unjustly, unreasonably, and discriminately charging [the named customer]* in this Complaint for its local exchange telephone service.

* For purposes of this Motion to Add, the words "named customer" shall mean IN EACH COMPLAINT all words EXCEPTING the words { "ON BEHALF OF***" }, which were struck in the above Number One [1] Motion to Strike.

4. STRIKE from each complaint the words beginning with "COMPLAINANT WWW" appearing on Page Four [4] of the Complaint and ending with the words "ten per cent." appearing on Page Five [5] of the Complaint, and

5. STRIKE from each complaint the words "on behalf" appearing in the last line on Page Five [5] of the Complaint, and

6. ADD the following paragraph to each complaint following the words "RESIDENTIAL SERVICE customer" appearing on Page Four [4]:

"Upon a finding that OHIO BELL, an Ohio public utility does, in fact, unlawfully, unjustly, unreasonably, and discriminately charge the named customer in this Complaint for its local exchange telephone service, then Complainant asks for that relief which is provided for by law."

MOTION TO RESCIND

Complainant hereby moves the Commission TO RESCIND ORDER contained in ENTRY docketed September 6, 1996, 96-492-TP-ACE et. al.

MOTIONS TO AMEND

Section 4901-9-01(A) [OAC] [Complaint Proceedings] reads in part as follows:


"All complaints filed under section 4905.26 of the Revised Code, except complaints filed by a public utility concerning a matter affecting its own product or service, shall be in writing and shall contain the name of the public utility complained against, a brief statement of the facts which constitute the basis of the complaint, and a statement of the relief sought....."

All Motions to Amend when granted will correct all complaints included in the captioned cases to conform with the requirement that complaints filed under section 4905.26 of the Revised Code "shall be in writing and shall contain the name of the public utility complained against, a brief statement of the facts which constitute the basis of the complaint, and a statement of the relief sought.




