The Commission finds:

- (1) On August 15, 1996, the complainant, Universal Medical Systems, Inc., *et al.*, (Universal) filed a complaint with the Commission against Communications Buying Group, Inc. (CBG, or respondent). In broad terms, the complainant alleges that CBG "slammed" Universal.
- (2) The parties have arrived at a mutually satisfactory resolution of the issues presented in this case. On December 12, 1996, the parties, through counsel, jointly filed a motion seeking voluntary dismissal of this case, with prejudice.
- (4) The parties' joint motion for dismissal of this case, with prejudice, shall be granted.

It is, therefore,

ORDERED, That, based on the joint request of the parties, Case No. 96-829-TP-CSS is dismissed, with prejudice, and closed as a matter of record. It is, further,


