- in item 6, the agent for service of process may be (a) a natural person who is a resident of Ohio, or (b) an Ohio corporation or a foreign corporation licensed in Ohio which is explicitly authorized by it arrucles to act as statutory agent and which has a business address in Ohio. (O.R.C. 1703,041)
- No foreign corporation which previously should have obtained a license to do business in Chio shall maintain any action in any court until it has obtained such a license.
