ENTRY

The Ohio Power Siting Board finds:

- (1) Between March 1976 and 1998, the Ohio Power Siting Board (Board) granted a number of transmission line certificates of environmental compatibility and public need to Ohio Edison Company (OE), The Toledo Edison Company (TE), and The Cleveland Electric Illuminating Company (CEI). All three of those companies are now operating subsidiaries of FirstEnergy Corp.
- (2) On October 27, 1999, the Federal Energy Regulatory Commission (FERC) approved FirstEnergy operating companies' application to transfer their transmission assets to another subsidiary, American Transmission Systems, Inc. (ATSI). FirstEnergy Corp. Operating Companies/American Transmission Systems, Inc., Docket No. EC99-53-000.

On February 17, 2000, the Public Utilities Commission of Ohio (Commission) approved the proposed transfer of the transmission assets of the FirstEnergy operating companies to ATSI. In the Matter of the Application of the FirstEnergy Operating Companies For Approval of the Transfer of Their Transmission Assets to American Transmission Systems, Inc., Case No. 98-1633-EL-UNC, Finding and Order (February 17, 2000). The Commission noted that the FERC's earlier decision had contemplated that the Commission would opine which assets would be designated as distribution facilities versus transmission facilities. The Commission concluded that the "distribution facilities versus transmission facilities" analysis would be best addressed in the then-pending transition plan cases of the operating companies. Therefore, the Commission concluded that the proposed transfer was approved, but subject to the Commission's ultimate identification of facilities involved. Id.

In July 2000, the Commission issued a decision in the transition plan cases of the operating companies. In the Matter of the Application of FirstEnergy Corp. on Behalf of Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company for Approval of Their Transition Plans and for Authorization to Collect Transition Revenues, Cases Nos. 99-1212-EL-ETP, et al. (July 19, 2000). Among the many conclusions reached in those cases, the Commission decided that the proposed classification of transmission facilities was appropriate. Id. at 56-58.

- On October 2, 2000, the operating companies requested, (3) pursuant to Section 4906.04, Revised Code, that all electric transmission line certificates granted to the operating companies be transferred to ATSI. The operating companies noted the FERC and Commission decisions mentioned above and, additionally, stated that the Pennsylvania Public Utilities Commission and Securities Exchange Commission have likewise approved of the transfer of ownership of the transmission facilities to ATSI. Thus, at the present time, all major transmission facilities certified by the Board are owned by ATSI. The operating companies then listed the certificates (and amendments) that they seek to have transferred to ATSI.1 The operating companies further noted that the transfer is intended to be an intermediate and facilitating step in a later transfer of transmission assets (and their operation) to a regional transmission organization. ATSI acknowledged its obligation to comply with all of the conditions of the newly acquired certificates.
- (4) No one filed a response to the certificate transfer request.
- (5) Pursuant to Section 4906.04, Revised Code, certificates may be transferred when the new owner agrees to comply with the terms, conditions, and modifications contained therein. Based upon the foregoing, the Board concludes that the following certificates of environmental compatibility and public need previously granted to the operating companies for the construction and operation of electric transmission facilities (and associated transmission facilities) should be transferred to ATSI. ATSI shall be bound by and comply with all terms and conditions of these certificates. The certificates that we authorize to be transferred are:
