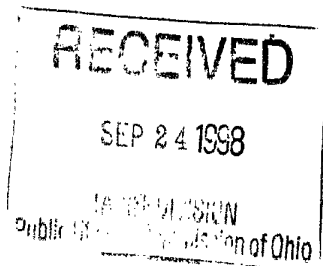

5. IntraLATA Presubscription Charges (Continued)

New customers who do not make an intraLATA toll carrier presubscription choice at the time the new customer places an order establishing local exchange service with the Telephone Company will not be presubscribed to any IntraLATA toll carrier, but rather will be required to dial a carrier access code to route all intraLATA toll calls to the carrier of choice for each call.

After a customer's initial selection for a presubscribed intraLATA toll carrier, for any change thereafter, an IntraLATA Presubscription Change Charge, as set forth in Paragraph 5.b. will apply.

b. Non-recurring Charges

(1) IntraLATA Presubscription Change Charge¹

Per business or residence line, trunk, or port

-- Initial line, trunk, or port \$5.00

-- Additional line, trunk, or port \$1.50

¹ When a customer simultaneously requests a change to their InterLATA carrier and their IntraLATA carrier, only the InterLATA change charge as specified in the interstate tariff applies.

6. IntraLATA Presubscription Implementation Charge

The IntraLATA Presubscription Implementation Charge is a \$.001606 per minute of use charge that is assessed to recover the Telephone Company's costs associated with the implementation of IntraLATA Presubscription. The charge is applied to all originating intraLATA switched access minutes generated on lines that are presubscribed for intraLATA service. The IntraLATA Presubscription Charge becomes effective one year and forty five days after the implementation date of IntraLATA presubscription, unless otherwise ordered by the Commission, and will remain in effect for three years.
