Dear Ms. Crockron:

Cincinnati Bell Telephone Company (CBT) proposes to revise its Out of Territory Services Tariff PUCO No. 1 to provide a special promotion to **residential** customers who subscribe to **Quiet Time Service**.

Residential customers who meet the terms of this promotion will receive a waiver of the nonrecurring charge of \$8.50 per line for Quiet Time Service and the first month's (30 days) recurring charge. This special promotion will be in effect from January 27, 2001 through March 5, 2001.
