

LEGAL NOTICE PUCO

The Public Utilities Commission of Ohio has scheduled local public hearings in Case No. 05-1305-TP-ORD to afford customers an opportunity to comment on a staff proposal that would authorize alternative regulation of basic local telephone service. The staff proposal is in response to legislation adopted by the Ohio General Assembly directing the Commission to adopt rules by March 4, 2006, authorizing alternative regulation of basic local telephone service. Under the proposal, incumbent local telephone companies that have an approved elective alternative regulation plan and have complied with all advanced services and Lifeline commitment could apply to the Commission for pricing flexibility of basic local exchange service and caller ID. Applicants would be required to prove that competition exists in their service territory; and final approval would be subject to Commission review. Local public hearings shall be scheduled as follows:

Cincinnati - Friday, Jan. 20, 2006, at 2:00 p.m., at Cincinnati City Hall, Council Chambers, 801 Plum Street, Cincinnati, Ohio;

Toledo - Monday, Jan. 23, 2006, at 5:00 p.m., at Toledo Government Center, Lucas County Commissioners hearing Room, 1 Government Center, First Floor, Toledo, Ohio;

Athens - Tuesday, Jan. 24, 2006, at 2:00 p.m., at Athens City Hall, Council Chambers, Third Floor, 8 East Washington Street, Athens, Ohio;

Dayton - Thursday, Jan. 26, 2006, at 5:00 p.m., at Dayton Municipal Building, City Commission Chambers, 101 W. Third Street, Dayton, Ohio.
