ENTRY

The attorney examiner finds:

- (1) Pursuant to Section 4935.04, Revised Code, and Rule 4901:5-3-01(C), Ohio Administrative Code, Vectren Energy Delivery of Ohio, Inc. (Vectren) filed its 2005 long-term gas forecast report (LTFR) on May 27, 2005, in Case No. 05-120-GA-FOR (2005-LTFR case).
- (2) On October 6, 2004, the Commission scheduled a hearing in Case No. 04-220-GA-GCR, Vectren's 2004 purchased gas adjustment clause case (2004-GCR case). However, because of delays in the assignment of the auditor in that case, that hearing was rescheduled by the attorney examiner to February 14, 2006.
- (3) On July 12, 2005, the attorney examiner granted staff's motion to consolidate the 2005-LTFR case and the 2004-GCR case for the purposes of hearing.
- (4) On August 9, 2005, in accordance with Section 4935.04(D), Revised Code, a public hearing was held at the offices of the Commission for the purpose of receiving public testimony in the 2005-LTFR case. The hearing was then continued until the time that the consolidated cases are scheduled for hearing. In that August 9, 2005 entry, the attorney examiner set the date for the hearing in the consolidated cases as February 14, 2006.
- (5) On August 24, 2005, the Commission issued its entry scheduling the hearing in the 2004-GCR case for October 17, 2006. Further, on September 14, 2005, the Commission ordered that Case No. 05-220-

GA-GCR, Vectren's 2005 purchased gas adjustment clause case (2005-GCR) be consolidated with the 2004-GCR case and both be scheduled for October 17, 2006.


- (6) Consistent with the July 12, 2005 consolidation order by the attorney examiner and in accordance with the orders of the Commission, the consolidated hearing in the three captioned cases will be held at the offices of the Commission, on Tuesday, October 17, 2006, at 10:00 a.m., in Hearing Room 11-F, 180 East Broad Street, Columbus, Ohio 43215.
- (7) Vectren shall comply with the publication requirements of Rule 4901:1-14-08(C), Ohio Administrative Code, and the Commission's September 14, 2005 entry, providing notice of the consolidated hearing for the 2004-GCR and the 2005-GCR cases, and the 2005-LTFR case.

It is, therefore,

ORDERED, That the continuation of the public hearing regarding Vectren's 2005-LTFR, consolidated with the hearing in the 2004-GCR and the 2005-GCR cases, is scheduled in Hearing Room 11-F, 180 East Broad Street, Columbus, Ohio 43215, at 10:00 a.m., on Tuesday, October 17, 2006. It is further,

ORDERED, That a copy of this Entry be served upon all parties of record.


