Dear Ms. Crockron:

Cincinnati Bell Telephone Company (CBT) proposes to revise its **Out of Territory Services Tariff PUCO No. 1** to conduct a promotional offering. **For each referred residential customer who signs up for local exchange service with CBT, the referring residential customer will receive a waiver of one month's recurring charges associated with select services they currently subscribe to. These services include the access line and any Custom Calling Services or Complete Connections Service.** There is no limit to the number of customer referrals. This promotional offering will be in effect beginning September 28, 2002 through October 31, 2002.

In accordance with the Commission's guidelines for promotional offerings established in Case No. 90-2021-TP-ATA, Case No. 90-5013-TP-TRF, Case No. 93-1020-TP-ATA and the Finding and Order in Case No. 99-1496-TP-UNC, to apply CBT's *Commitment 2000 Plan* to CBT's operations outside of its existing territory, we are forwarding for filing three copies of the tariff pages describing the promotional offerings. The new tariff pages specify the rate and terms that will be in effect for the service included in this promotion.
