Revised tariff sheets have been filed with the FCC to amend Verizon Tariff FCC No. 14, Facilities for Interstate Access, in which Verizon North Inc. concurs for intrastate applications, except as otherwise ordered by the PUCO on June 27, 2002 in Case No. 00-127-TP-COI.

In accordance with your Commission's Order in Case No. 83-464-TP-COI, we are filing four (4) copies of these revised tariff sheets.

This filing includes revisions to tariff pages and supporting data for the Third Quarter 2003 Federal Universal Service Fund charge. This filing is being made in compliance with the following Federal Communications Commission order:

In the Matter of Access Reform, Price Cap Performance Review for Local Exchange Carriers, Low-Volume Long Distance Users, Federal-State Joint Board on Universal Service, Sixth Report and Order in CC Docket Nos. 96-262 and 94-1, Report and Order in CC Docket 99-249, Eleventh Report and Order in CC Docket 96-45 (rel. May 31, 2000);

In the Matter of Federal-State Joint Board on Universal Service, Report and Order and Second Further Notice of Proposed Rulemaking, FCC 02-329, (rel. December 13, 2003); and

In the Matter of Federal-State Joint Board on Universal Service, Order and Second Order on Reconsideration, FCC 03-58 (rel. March 14, 2003).

Due to changes in the Federal Communication Commission's Universal Service Fund methodology, Verizon is introducing a new FUSF Surcharge on Incidental Charges. In Tariff F.C.C. Nos. 14 and 16, the incidental charges consist of the Presubscribed Interexchange Carrier (PIC) change charge and the end-user PICC; while in Tariff F.C.C. Nos. 1 and 11, the incidental charges consist of only the PIC change charge. Lifeline customers will continue to be exempt from the FUSF surcharge(s) on all supported services, but they will not be exempt from the FUSF surcharge on incidental charges.

The Universal Service Fund (USF) charge provides for affordable local telephone service for all customers and provides a discount to schools, libraries and low-income families.

The USF charge will be assessed to end user customers who order Special Access Services, from this tariff. (T)
The USF charge will be determined by multiplying a USF Surcharge factor of .095 by the end user customer's monthly billing account level interstate charges for these services. (I)

The USF charge will also be assessed to end user customers on Other Incidental Charges. A USF Surcharge factor of .095 will be applied to the following nonrecurring charges: (N)

- Nonrecurring Charge for Presubscribed Interexchange Carrier
- Primary Interexchange Carrier Charge

To the extent the Nonrecurring Charge for Presubscribed Interexchange carrier is billed to an IC, as set forth in 6.5(F) and 6.5(G), the USF Surcharge will apply to the IC. (N)

The USF charge, as shown in this section of the tariff, shall be assessed to customers that are billed end user common line charges. These USF charges will not be assessed to Lifeline customers, with the exception of the USF on Other Incidental Charges. (T)
