Cincinnati Bell Telephone Company (CBT) proposes to revise **Out of Territory Services Tariff**, PUCO No. 1 to provide a special promotion of its **Asymmetrical Digital Subscriber Line Service (ADSL) TurboSpeed** package. **Residential** customers who subscribe to ADSL TurboSpeed Service will receive a **\$20.00 monthly discount toward the first three months' recurring charges** associated with ADSL. This special promotion is available beginning October 1, 2001 through December 31, 2001.
