ENTRY

The Commission finds:

- (1) The applicant, The Cincinnati Gas & Electric Company (CG&E), is a public utility as defined in Section 4905.02, Revised Code, and, as such, is subject to the jurisdiction of the Public Utilities Commission of Ohio. Section 4905.31, Revised Code, authorizes reasonable arrangements between a gas utility and its customers, conditioned upon approval by the Commission.
- (2) On April 11, 2001, CG&E filed applications in Case Nos. 01-838-GE-AEC, 01-839-GE-AEC, 01-840-GE-AEC, 01-841-GE-AEC, 01-842-GE-AEC, and 01-843-GE-AEC, for approval of summary billing agreements with the following customers, respectively: Middletown Monroe City Schools; Vukelic, Inc.; GTE Mobilnet, Inc.; Mike Albert Leasing, Inc.; Three Rivers Local School District; and the Board of County Commissioners of Hamilton County.
- (3) On May 1, 2001, CG&E filed applications in Case Nos. 01-1044-GE-AEC, 01-1045-GE-AEC, 01-1046-GE-AEC, 01-1047-GE-AEC, and 01-1048-GE-AEC, for approval of summary billing agreements with the following customers, respectively: Hills Real Estate Group, Sterling Lakes; Hills Real Estate Group, Fox Chase North; Hills Real Estate Group, Waterford Place; Hills Real Estate Group, Island Club; and Hills Real Estate Group, Landings at Beckett Ridge.



- (4) On August 1, 2001, CG&E filed an application for Commission approval of a new tariff rider relating to an optional summary billing service (SBS) pilot, in Case No. 01-1933-GE-ATA. This pilot, as described in the application, covers the same services as would have been provided pursuant to the agreements described in the cases listed in paragraphs (2) and (3). The Commission approved CG&E's tariff rider for SBS by a Finding and Order dated April 11, 2002.
- (5) On May 24, 2002, CG&E filed notices stating its intention to withdraw all of the applications listed in paragraphs (2) and (3), as the summary billing service covered by those applications is now available under the SBS rider.
- (6) The Commission agrees with CG&E that such summary billing agreements are unnecessary and that these matters should be closed of record.

It is, therefore,

ORDERED, That Case Nos. 01-838-GE-AEC, 01-839-GE-AEC, 01-840-GE-AEC, 01-841-GE-AEC, 01-842-GE-AEC, 01-843-GE-AEC, 01-1044-GE-AEC, 01-1045-GE-AEC, 01-1046-GE-AEC, 01-1047-GE-AEC, and 01-1048-GE-AEC are closed of record. It is, further,

ORDERED, That a copy of this Entry be served upon all parties of record.


