Dear Ms. Crockron:

Cincinnati Bell Telephone Company (CBT) proposes to revise its **Out of Territory Services Tariff PUCO No. 1 in order to conduct a promotion on all nonresidential services.** This promotion offers **new business customers** who subscribe to any of the business services contained in the tariff, a waiver of the nonrecurring charges associated with these services and a waiver of the 13th month recurring charges associated with these services. This promotion will be in effect from January 1, 2002 – December 31, 2002.

In accordance with the Commission's guidelines for promotional offerings established in the cases referenced above and the Finding and Order in Case no. 99-1596-TP-UNC, which requires CBT to apply it's Commitment 2000 Plan to operations outside of its existing territory, we are forwarding for filing three copies of the tariff pages describing the promotional offerings. The new tariff pages specify the rate and terms that will be in effect for the services included in these promotions.
