

**MEMORANDUM IN SUPPORT OF THE JOINT MOTION FOR
EXTENSION OF TIME**

The Cincinnati Gas & Electric Company (CG&E), The Village of Amberley, Ohio (Amberley), and Time Warner Telecom of Ohio, LLC (TWTC) (collectively, "Parties"), respectfully request an extension of the hearing date in this case from January 17, 2006, to a date which is approximately four weeks from the date of the Commission's decision in case number 05-75-EL-PWC. CG&E, Amberley, and TWTC believe that the Commission's decision in the Forest Park Proceeding will assist them in discussions to settle this case. The Parties expressly waive the requirement imposed by R. C. 4939.06(A) that the Commission "act to resolve the complaint by issuance of a final order within one hundred twenty days after the date of the complaint's filing."¹ CG&E, Amberley, and TWTC do not believe that the extension of time will result in prejudice to any party.

Moreover, if the Commission extends the hearing date in this matter the Parties further request that the Commission extend the date for the filing of direct testimony to seven days prior to the rescheduled hearing date and terminate the telephonic prehearing conference scheduled on January 10, 2006. The November 7, 2005, Commission order in this proceeding required that all direct testimony be filed by January 10, 2006, and that a prehearing telephonic conference be held on that same date.


