Enclosed for filing is an original and three (3) copies of Cincinnati Bell Telephone Company's (CBT's) approved tariff filing which revised the **General Exchange Tariff**, PUCO No. 8, Section 51 to offer two new business services packages – **23 Line Prime Advantage with Small Office DSL and 24-Line Trunk Advantage with Small Office DSL**. As with the existing eight Business Service Packages in Section 51, these packages contain a combination of voice, data and value-added services which are individually tariffed in CBT's General Exchange and Exchange Rate tariffs.

BUSINESS SERVICE PACKAGES

B. TERMS AND CONDITIONS

1. The components of a Business Service Package are not to be split among multiple Customers. The packages are to be sold on per customer, per location basis. Customers will be limited to one package, per location.
2. If a Customer disconnects any of the services included in a Business Service Package they will still be responsible for the entire monthly rate of the package.
3. Business Service Packages are only available under 36-month term agreements.
4. If a Customer terminates service, without cause, prior to the expiration of the term, the Customer will pay to CBT a termination charge equal to all remaining amounts due or to become due, including but not limited to all monthly charges for which Customer would have been responsible if the customer had not terminated prior to the end of the applicable 36-month term payment plan. (See Note)
5. Upon completion of the 36-month term agreement the Customer may renew their contract at the current, tariffed rates for the Business Service Packages. If the Customer does not renew their contract prior to the expiration date and does not elect to discontinue the Business Service Package, service will be continued, but the Customer will be required to pay the individual tariffed rates associated with each service in the Package.
6. When establishing a Business Service Package as a new service or when moving an existing service to a different address the nonrecurring charges will be applied.

Note: Commission approval of the termination liability for these Business Service Package contracts, as described above, is not intended to indicate that the Commission has approved or sanctioned any terms or provisions contained therein. Signatories to such contracts shall be free to pursue whatever legal remedies they may have should a dispute arise.
