Sprint Bill billboard which will run Oct. 6 and Nov. 6 for Kinsman, and Oct. 10 and Nov. 10 for Greene (Two complete cycles prior to ELC cutover).

On November 17, 1999, Sprint's local customers in the Greene 583 exchange and the Kinsman 876 exchange will have two-way measured rate local service, known as extended local calling (ELC).

As a result, Greene and Kinsman customers will save approximately 70 percent on toll rates and do not have to dial "1" or the area code when calling between exchanges.


The ELC rate between Greene and Kinsman will be \$0.047 per minute from 8 a.m. to 9 p.m. weekdays and \$0.028 per minute from 9 p.m. to 8 a.m. weekdays and all day on Saturdays, Sundays and holidays.

Customers will see all ELC calls added together on their bill. Customers wanting an itemized listing of these ELC calls may contact the business office listed on their phone bill to receive an itemized list on a per-request basis.
