

9. SPECIAL PROMOTIONS

9.08. The Company will offer the following promotion starting April 15, 2004 and ending no later than June 13, 2004.

The Company will waive the \$500.00 Nonrecurring Charge for customers who subscribe to CyberDS1 under a Term Commitment or a Term and Volume Plan.

9.10. The Company will offer the following promotion starting October 25, 2004 and ending no later than December 24, 2004.

Business customers changing existing local exchange service to Verizon from another local service provider will receive a certificate valued at the nonrecurring charges associated with the re-establishment of local exchange service. The certificate issued to the customer will be in the form of a check payable to Verizon. The applicable nonrecurring charges are set forth in Section 2.

9.11. The Company will offer the following promotion starting January 31, 2005 and ending no later than April 1, 2005.

Residential customers changing their existing local service from another local service provider to Verizon as a result of Verizon's direct mail campaign and select either Verizon Local Packagesm, Verizon Local Package Extrasm, Verizon Regional Packagesm, or Verizon Regional Package Extrasm for their local service are eligible to receive an American Express Gift Certificate (AMEX). Customers who respond to the initial offer and subscribe to one of the above services during this promotion are eligible for a \$25 AMEX check.
