On April 30, 2003, The Cincinnati Gas & Electric Company (CG&E) filed an application with the Commission to revise its Percentage of Income Payment Plan (PIPP) rider rate to gas customers. Pursuant to the procedure established by the Commission in the Opinion and Order in Case Nos. 88-1115-GE-PIP et al., supra, CG&E is permitted to implement a revised PIPP rider rate on the 46th day after its application absent any actions to the contrary. Since there have been no objections to the rate proposal, the Company intends to implement the proposed rider rate effective June 16, 2003.
