Cincinnati Bell Telephone Company (CBT) proposes to revise **Out of Territory Services Tariff**, PUCO No. 1 to conduct a special promotion of its **Asymmetrical Digital Subscriber Line Service** (**ADSL**) for **residential** customers. Residential customers who subscribe to ADSL TurboSpeed Service will receive a **\$19.95 monthly discount toward the first three months' recurring charges** associated with ADSL. This special promotion is available beginning January 1, 2002 through March 31, 2002.
