Cincinnati Bell Telephone Company (CBT) proposes to revise **Out of Territory Services Tariff**, PUCO No. 1 to conduct a special promotion of its **Asymmetrical Digital Subscriber Line Service (ADSL)** for **residential** customers. Residential customers who subscribe to ADSL TurboSpeed Service will receive a **\$19.95 monthly discount toward the first three months' recurring charges** associated with ADSL. This special promotion is available beginning January 1, 2002 through March 31, 2002.

In accordance with the Commission's guidelines for promotional offerings established in Case No. 90-2021-TP-ATA, Case No. 90-5013-TP-TRF, Case No. 93-1020-TP-ATA and the Finding and Order in Case No. 99-1496-TP-UNC, to apply CBT's *Commitment 2000 Plan* to CBT's operations outside of its existing territory, we are forwarding for filing three copies of the tariff pages describing the promotional offerings.
