
ORDERED, That those filing comments or reply comments serve those comments as set forth in Finding 3, above. It is, further,



4901-5-07 Original applications for interstate registration.

Interstate motor carriers for hire operating within or through the state of Ohio must register their operations with this commission. Applications for such registration must be made upon the form provided by the commission and designated as "Application for Registration as an Interstate Motor Carrier for Hire." Such applications must be executed as required in section 4919.79 of the Revised Code.

4901-5-08 Application to amend interstate registration.

When the operating rights granted to an interstate motor carrier for hire are amended by an order of the interstate commerce commission, an application must be filed with this commission for an amendment of the acknowledgement of registration of such interstate motor carrier. Such application must be filed on the form provided by the commission and designated as "Application for Amended Registration of Interstate Motor Carrier for Hire."

4901-5-09 Application to transfer acknowledgement of registration of interstate motor carrier.

A purchaser or transferee of the operating rights of an interstate motor carrier must file with this commission an application for the transfer of the registration of such interstate motor carrier. This application must be executed upon forms provided by the commission and designated "Application to Transfer Registration of Interstate Motor Carrier for Hire." A copy of the order of the interstate commerce commission authorizing the transfer or purchase of the operating rights of such interstate motor carrier must be attached to the application.
