ANSWER AND MOTION TO DISMISS OF THE CLEVELAND ELECTRIC ILLUMINATING COMPANY

Comes now Respondent, The Cleveland Electric Illuminating Company, by counsel, and for its Answer to the Complaint filed in the instant action says that:

- 1. The Cleveland Electric Illuminating Company is a public utility, as defined by §4905.03(A)(4), O.R.C. and is duly organized and existing under the laws of the State of Ohio.
- 2. CEI admits that it currently has an electric service account in the name of Edmund A. Zaller and a service address of 5687 Cliff Court, Willoughby, Ohio.
- 3. CEI admits that Complainant requested CEI to perform services on his property, specifically the disconnection and reconnection of electric service.
- 4. CEI admits that it charged Complainant for the requested services in accordance with its Commission-approved tariffs, rules and regulations, and that Complainant was charged the same amount for the services as similarly situated customers.

- 5. CEI denies that it charges customers to locate CEI's electrical lines in an underground development, and further denies that Complainant was charged any such amount.
- CEI denies that any amount of money is owed to or should be refunded to
 Complainant by CEI.
- 7. CEI generally denies all allegations set forth in the Complaint which were not otherwise specifically addressed hereinabove.

For its affirmative defenses, the Company further avers that:

- 8. CEI breached no legal duty owed to Complainant, and Complainant failed to state reasonable grounds upon which its requested relief may be granted.
- 9. CEI has at all times acted in accordance with its Tariff on file with the Public Utilities Commission of Ohio, as well as all rules and regulations as promulgated by the Public Utilities Commission of Ohio, the laws existing in the State of Ohio, and accepted standards and practices in the electric utility industry, and CEI denies that its rates, charges, or services are unjust or unreasonable.

For its Motion to Dismiss, CEI states the following:

10. Complainant seeks to not be charged for a service that CEI is expressly permitted to charge pursuant to its Tariff, and that is charged on a non-discriminatory basis to all similarly situated customers. CEI is under an obligation to treat all similarly situated customers in a similar fashion, and granting the Complainant's request would cause CEI to violate this obligation.

11. Given the complaints made and relief sought in the Complaint, it does not appear at this point that any reasonable grounds for the Complaint exist. CEI would request that this matter be dismissed.

WHEREFORE, having fully answered the Complaint, Respondent, The Cleveland Electric Illuminating Company, respectfully requests that the instant action be dismissed, and that it be granted any other relief that this Commission may deem just and reasonable.
