LEGAL NOTICE

The Public Utilities Commission of Ohio has scheduled a hearing in Case No. 05-765-EL-JUNC, being in the Matter of the Transfer of Power Monongahela Power Company's Certified Territory in Ohio to the Columbus Southern Power Company. An evidentiary hearing is scheduled for Tuesday, Oct. 11, 2005, at 10:00 a.m., in hearing room 11-F at the offices of the Commission, 180 East Broad Street, Columbus, Ohio. The hearing will address the proposed acquisition of Monongahela Power Company's Ohio certified service territory by Columbus Southern Power Company and proposed customer rates. Columbus Southern Power Company has proposed that in the customers' power Monongahela Power Company's present Ohio certified service territory be changed the rates established in Columbus Southern Power Company's Rate Stabilization Plan except that Monongahela Power Company's large commercial and industrial cus-

tomers will be assessed a nonypassable surcharge on a per kWh basis set at a level to produce \$10 million over an approximately five-year period. In addition, Columbus Southern Power Company proposes that it be permitted to recover the difference between its power acquisition costs and the revenues produced under its rates for the rate stabilization period January 1, 2006 through December 31, 2008. The difference for the first year is expected to be approximately \$17 to \$19 million. Columbus Southern Power Company seeks approval, as part of this proceeding, to collect this amount from all of its current and new customers at a generation surcharge level based upon expected power load in 2006. Recommendations that differ from the companies' proposals may be made by the staff of the Public Utilities Commission of Ohio or by intervening parties and may be adopted by the Commission.
