Dear Ms. Crockron:

Cincinnati Bell Telephone Company (CBT) proposes to revise its **Out of Territory Services Tariff** PUCO No. 1 to provide a special promotion of its Complete Connections Service. **Residential** customers, who establish new local exchange service and subscribe to Complete Connections Service during the period of November 15, 2002 through December 31, 2002, will **save \$5 off the monthly recurring rate for Complete Connections Service during the first three months**. This promotion cannot be used in conjunction with any other existing Complete Connection promotions regarding the monthly recurring charge.
