Dear Ms. Crockron:

On September 1, 2000 Cincinnati Bell Telephone Company (CBT) filed a promotional tariff in order to conduct a promotion on its LAN Advantage® Service. This promotion offered business customers, who subscribed to the LAN Advantage® Service during the promotional period, a waiver of the nonrecurring charges associated with the service. This promotion was approved by the Commission and was to be in effect from September 1, 2000 through November 30, 2000. On November 4, 2000 CBT extended this promotion to December 31, 2000.

With this filing CBT is requesting permission to **amend** the LAN Advantage® promotion a second time in order to extend the promotional period to **January 31, 2001**. The terms and conditions of the promotion established in the September 1, 2000 filing will continue to apply.
