ENTRY

The Commission finds:

- (1) On May 30, 1995, Robert Slusher and other subscribers of the Orwell Exchange of the Orwell Telephone Company (Orwell) filed a petition with the Commission requesting that the boundary between the Orwell Exchange and the North Bloomfield Exchange be changed so that the petitioners would be located in the North Bloomfield Exchange of Orwell.
- (2) By letter filed April 8, 1997, the Commission was advised that the parties have entered into an agreement whereby Orwell will move the boundary between the Orwell and North Bloomfield exchanges to coincide with the Ashtabula and Trumbull county boundary. As a result, the petitioners will receive service from the North Bloomfield Exchange. Orwell has agreed to implement the change by April 1, 1998. Pursuant to the agreement, the petitioners have filed a motion to dismiss the complaint.
- (3) The Commission, being advised that the parties have reached an agreement and finding that the terms of the agreement are reasonable, finds that the complaint should be dismissed.

It is, therefore,

ORDERED, That the motion to dismiss is granted and, therefore, this case is dismissed and closed of record. It is, further,
